New Law Changes:

Please stay tuned as we will be updating you soon on all the changes that will be occurring due to recent changes in Law. One of the major ones is the five year limit on TANF which is retroactive.

GA Maximums:

The GA Maximums will be sent out before October 1st. Please remember to start using these even if they have not been adopted by October 1st. Unlike Ordinances in most Towns and Cities, this one only requires a vote by the Selectmen/Board/Council. However, don't forget to follow the public hearing process, such as posting and advertising.
